An Act to Require Voter Approval of the Disposal of Low-level Radioactive Waste. Presented by Energy & Natural Resources Hearing 03-27-85. Majority OTP-ND-NT Accepted (Minority O.T.P.). NEW DRAFT: HP1141 / LD 1649 (Competing Measure), NEW TITLE: An Act to Establish a State Policy Relating to the Disposal of Low-level Radioactive Waste. Enacted, Approved 06-28-85, PUBLIC LAWS, Chapter 493. Both the Original Bill (Question A) and the Competing Measure (Question B) were submitted for ratification on 11-05-85. Question A was approved and Question B failed (In favor of Question A: 86,678; In favor of Question B: 45,920; Opposed to both questions: 39,893). INITIATED BILL, Chapter 1.
