LD 750 / HP0530

An Act to Provide for the Negotiability of Transfers, Reassignments and Promotions for Teachers. Presented by Rep. Baker of Portland; Co-sponsored by Rep. Clark of Millinocket, Rep. Mayo of Thomaston, Sen. Gauvreau of Androscoggin. Labor Hearing 3-19-85. Majority OTP-AM Accepted by Senate (Minority O.N.T.P.). House - Indefinitely Postponed. Recommitted to Labor. Leave to Withdraw Accepted.
