Communication from Deputy Secretary of State: Transmitting initiated bill, "An Act to Prohibit the Promotion and Wholesale Promotion of Pornographic Material in the State of Maine" (I.B. 2) (L.D. 2092). Ordered Placed on File, in Concurrence, 03-03-86.

An Act to Prohibit the Promotion and Wholesale Promotion of Pornographic Material in the State of Maine. Judiciary Hearing 03-27-86. Majority O.N.T.P. Accepted 04-07-86 (Minority OTP). Failed in Referendum 06-10-86 (In favor: 81,970; Opposed: 209,537).

Joint Order, That the Office of the Secretary of State submit to the electors of the State for determination by the people at the next statewide election to be held June 10, 1986, the subject matter of "An Act to Prohibit the Promotion and Wholesale Promotion of Pornographic Material in the State of Maine." Presented by Rep. Paradis of Augusta. Passed in Concurrence, 04-14-86. (See LD 2092)

Joint Order, That the Office of the Secretary of State submit to the electors of the State for determination by the people at the next general election to be held November 4, 1986, the subject matter of "An Act to Prohibit the Promotion and Wholesale Promotion of Pornographic Material in the State of Maine." Presented by Rep. Murphy of Kennebunk. Indefinitely Postponed in House, 05-29-86. (See LD 2092)
