LD 539 / SP0192 (ND 2520 / SP0952)

AN ACT to Reform Provisions of the Civil Justice System. Presented by Sen. Twitchell of Oxford; Co-sponsored by Sen. Perkins of Hancock, and Rep. Vose of Eastport. Judiciary. Pursuant to Joint Order SP 555, this Bill was Carried Over from a Previous Session. Judiciary Hearing 01/21/88. OTP-ND Accepted 03/17/88. NEW DRAFT: SP0952 / LD 2520. Enacted, Approved 03/30/88, PUBLIC LAWS, Chapter 646.
