LD 1919 / HP1415

AN ACT to Encourage Prompt and Peaceful Settlements of Labor Disputes. Presented by Rep. Joseph of Waterville; Co-sponsored by Rep. Martin of Eagle Lake, Sen. Pray of Penobscot, and Sen. Dutremble of York. Labor. Majority OTP Accepted 11/20/87 (Minority ONTP). Amended by: HA H-435, HB H-436. Enacted, Veto Sustained 01/20/88.

Joint Order, That the Joint Standing Committee on Labor report out Bill, "An Act to Encourage Prompt and Peaceful Settlements of Labor Disputes," HP 1415, LD 1919, to the House. Presented by Rep. McHenry of Madawaska. Passed in Concurrence, 11/20/87.

SP0756

Joint Order, That Bill, "An Act to Encourage Prompt and Peaceful Settlements of Labor Disputes," HP 1415, LD 1919, be recalled from the Governor's desk to the Senate. Presented by Sen. Clark of Cumberland. Indefinitely Postponed in Concurrence, 01/07/88.
