LD 762 / SP0289

An Act to Establish the Maine Medical Malpractice Act. Presented by Sen. Gauvreau of Androscoggin; Co-sponsored by Rep. Manning of Portland, Rep. Burke of Vassalboro, and Rep. MacBride of Presque Isle. Judiciary Hearing 12/18/89. Recommitted to Judiciary in Senate; Indefinitely Postponed in House. Senate - Insisted on Recommit; House - Adhered to Indefinite Postponement. Final Disposition: Died Between Houses.
