**History and Final Disposition**

LD 66 / SP0042

RESOLUTION, Proposing an Amendment to the Constitution of Maine to Provide State Funding of any Mandate Imposed on Municipalities. Presented by Sen. Clark of Cumberland; Co-sponsored by Sen. Cleveland of Androscoggin, Rep. Mayo of Thomaston, and Rep. Gwadosky of Fairfield. State & Local Government Hearing 02/20/91. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1396, this Bill was Recalled from the Legislative Files. Recommitted to State & Local Government. Majority OTP-AM Accepted 03/25/92 (Minority ONTP). Amended by: CB S-527, HD/CB H-1237, SB S-555. Finally Passed, CON RES LAWS, Chapter 2. Final Disposition: Approved in Referendum 11/03/92 (In favor: 327,249; Opposed: 278,518).
