RESOLUTION, Proposing an Amendment to the Constitution of Maine to Protect the Assets of State Retirement Plans. Presented by Sen. Bustin of Kennebec; Co-sponsored by Rep. Mitchell of Vassalboro, Rep. Paradis of Augusta, and Sen. Pearson of Penobscot. State & Local Government Hearing 03/13/91. OTP-AM Accepted 04/25/91. Amended by: CA S-82. Finally Passed, CON RES LAWS, Chapter 1. Final Disposition: Approved in Referendum 11/05/91 (In favor: 262,113; Opposed: 111,705).
