Rydell of Brunswick. Human Resources Hearing 04/01/91. OTP-AM Accepted 05/06/91. Amended by CA S-106. Emergency Enacted. Pursuant to Joint Order SP 717, this Bill was Recalled from the Governor's Desk. Amended by: CA S-106, SA/CA S-376. Final Disposition: Emergency Enacted, Approved 07/10/91, PUBLIC LAWS, Chapter 545.
