HP0051

Joint Order, Directing the Joint Standing Committee on Appropriations and Financial Affairs to meet as an investigating committee to thoroughly study the anticipated revenues and incomes of State Government and all of its departments, agencies, authorities, bureaus, offices or other bodies or officials, from any sources and all presented appropriated or anticipated expenditures, and to report to the Legislature its findings, together with any proposals and proposed legislation. Presented by Speaker MARTIN of Eagle Lake. Final Disposition: Passed in Concurrence 12/21/90. (See LD 274, LD 275, LD 1882, LD 1951, LD 1961, LD 1973, LD 1984)

LD 1973 / HP1384

An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 for the Purchase of Recycling Equipment and Facilities and for the Remediation and Closure of Solid Waste Landfills. (Reported Pursuant to Joint Order HP 51). Appropriations and Financial Affairs. OTP Accepted 07/10/91. Died on Adjournment 07/10/91. Pursuant to Joint Order SP 783, this Bill was Recalled from the Legislative Files. Enacted, Approved 07/30/91, P & S LAWS, Chapter 69. Final Disposition: Failed in Referendum 11/05/91 (In favor: 185,577; Opposed: 190,078).
