RESOLUTION, Proposing an Amendment to the Constitution of Maine to Clarify Succession to the Positions of Treasurer of State and Secretary of State. Presented by Rep. Mayo of Thomaston; Co-sponsored by Rep. Poulin of Oakland, Rep. Gwadosky of Fairfield, and Sen. Clark of Cumberland. State & Local Government Hearing 01/22/92. OTP-AM Accepted 02/25/92. Amended by: CA H-932, HA/CA H-1032. Finally Passed, CON RES LAWS, Chapter 3. Final Disposition: Approved in Referendum 11/03/92 (In favor: 396,409; Opposed: 219,822).
