Referred to Joint Standing Committee on Banking and Insurance. Public Hearing 02/09/93. Majority OTP-AM Accepted 03/15/93 (Minority ONTP). Amended by: CA H-31. House: Adhere to Emergency Enactment; Senate: Adhere to Failure of Emergency Enactment. Final Disposition: Died Between Houses 04/12/93.
