An Act to Amend the School Funding Formula. Presented by Representative SKOGLUND of St. George; Cosponsored by Senator PINGREE of Knox and Representatives: ADAMS of Portland, GRAY of Sedgwick, HEINO of Boothbay, KERR of Old Orchard Beach, MELENDY of Rockland, SIMONEAU of Thomaston. Referred to Joint Standing Committee on Education. No Public Hearing. Majority OTP-AM Accepted 04/12/94. Amended by: CA H-1110, HD/CA H-1119. Final Disposition: Enacted, Signed 04/15/94, PUBLIC LAWS, Chapter 684.
