An Act Regarding the Holding of Juveniles in the Penobscot County Jail. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.) Presented by Representative CASHMAN of Old Town; Cosponsored by Representative RUHLIN of Brewer, Senator BALDACCI of Penobscot and Representatives: CAMPBELL of Holden, CLARK of Millinocket, COFFMAN of Old Town, CROSS of Dover-Foxcroft, FAIRCLOTH of Bangor, HUSSEY of Milo, MICHAUD of East Millinocket, MORRISON of Bangor, PLOWMAN of Hampden, SAXL of Bangor, STEVENS of Orono, STROUT of Corinth.
