New Title: Resolve, to Direct the Department of Environmental Protection to Collect, Review and Develop Information for Use in Implementing the Clean Air Act. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Representative CLARK of Millinocket. Referred to Joint Standing Committee on Energy and Natural Resources. Public Hearing 03/11/94. OTP-AM Accepted 03/28/94. Amended by: CA (Changed Title) H-911. Final Disposition: Emergency Finally Passed, Signed 04/08/94, RESOLVE LAWS, Chapter 67.
