An Act to Protect the Rights of Employees and to Ensure the Proper Expenditure of Public Funds. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by Representative CHASE of China; Cosponsored by Senator HANDY of Androscoggin and Representative: RUHLIN of Brewer, Senator: BUSTIN of Kennebec. Referred to Joint Standing Committee on Labor. Public Hearing 02/16/94. Majority OTP-AM Accepted 03/30/94. Amended by: CA H-865, SB/CA S-575. Final Disposition: Enacted, Veto Sustained 04/14/94.
