An Act to Encourage Municipal Investment in Local Economic Development Projects. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.) Presented by President DUTREMBLE of York; Cosponsored by Senators: BALDACCI of Penobscot, SUMMERS of Cumberland, Representatives: KERR of Old Orchard Beach, NADEAU of Saco. Referred to Joint Standing Committee on Taxation. Public Hearing 02/10/94. Majority OTP-AM Accepted 04/08/94. Amended by: CA S-468, HA H-1077. Final Disposition: Emergency Enacted, Signed 04/15/94, PUBLIC LAWS, Chapter 696.
