An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 to Expand and Improve the State's Distance Learning Infrastructure. Presented by Senator AMERO of Cumberland; Cosponsored by Senator: O'DEA of Penobscot, Representatives: MITCHELL of Vassalboro, NORTON of Winthrop, SIMONDS of Cape Elizabeth, SMALL of Bath.
