Final Disposition: Ordered Placed on File in Concurrence 03/30/94.

LD 1983 / IB0002

An Act to Impose Term Limits on Members of the United States Congress. (Transmitted to the Clerk of the House of the 116th Maine Legislature by the Secretary of State 03/17/94.) Referred to Joint Standing Committee on State and Local Government. No Public Hearing. Minority ONTP Accepted 04/07/94. Final Disposition: Approved in Referendum 11/08/94 (In favor: 312,007; Opposed: 182,192), INITIATED BILL, Chapter 2. (This law was subsequently declared unconstitutional, see League of Women Voters of Maine v. Diamond, No. 94-377-P-H (D. Me., May 26, 1995).)
