Presented by Representative THOMPSON of Naples. Referred to Joint Standing Committee on Judiciary. Public Hearing 02/25/98. Majority (OTP-AM) Accepted 03/25/98. Amended by: CA H-998, SA/CA S-718. Final Disposition: Enacted, Signed 04/16/98, PUBLIC LAWS, Chapter 770.
