An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government and Changes to Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1998 and June 30, 1999. (GOVERNOR'S BILL). Presented by Representative KERR of Old Orchard Beach; Cosponsored by Senator MICHAUD of Penobscot. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 01/06/98. Majority (OTP-AM) Accepted 03/31/98. Amended by: CA H-1098, HE/CA H-1109, HG/CA H-1111. Final Disposition: Enacted, Signed 04/01/98, PUBLIC LAWS, Chapter 643.
