LD 1984 / HP1420

An Act to Amend the Laws Governing Secession. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative DUTREMBLE of Biddeford; Cosponsored by Representatives: BUMPS of China, BOLDUC of Auburn, CARLETON of Wells, FRECHETTE of Biddeford, GIERINGER of Portland, LEMKE of Westbrook, SANBORN of Alton, Senator LaFOUNTAIN of York. Referred to Joint Standing Committee on State and Local Government. Public Hearing 02/11/98. Majority (OTP-AM) Accepted 03/25/98. Amended by: CA H-1024. Final Disposition: Enacted, Signed 04/03/98, PUBLIC LAWS, Chapter 699.
