An Act to Broaden the Farm Stand Exemption. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator FERGUSON of Oxford; Cosponsored by Senators: CAREY of Kennebec, CASSIDY of Washington, GOLDTHWAIT of Hancock, NUTTING of Androscoggin, Representatives: DEXTER of Kingfield, SPEAR of Nobleboro, TUTTLE of Sanford. Referred to Joint Standing Committee on Transportation. Public Hearing 02/02/98. Majority (OTP-AM) Accepted 03/18/98. Amended by: CA S-515. Final Disposition: Enacted, Signed 03/30/98, PUBLIC LAWS, Chapter 635.
