An Act to Create a Senior Lobster and Crab Fishing License. Presented by Representative HONEY of Boothbay; Cosponsored by Senator KILKELLY of Lincoln and Representatives: PIEH of Bremen, PINKHAM of Lamoine, RINES of Wiscasset. Referred to Joint Standing Committee on Marine Resources. Public Hearing 03/16/99. House: Insist on Majority (ONTP) 04/14/99, Conference Committee 04/14/99, Unable to Agree 05/12/99. Senate: Insist on Minority (OTP-AM) 04/15/99, Conference Committee 04/15/99, Unable to Agree 05/13/99. Final Disposition: Died Between Houses 05/13/99.
