Presented by Senator GOLDTHWAIT of Hancock; Cosponsored by Senator RUHLIN of Penobscot, Representatives: PINKHAM of Lamoine, POVICH of Ellsworth, VOLENIK of Brooklin. Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/26/00. OTP-AM Accepted 02/29/00. Amended by: CA S-497. Final Disposition: Enacted, Signed 03/15/00, PUBLIC LAWS, Chapter 554.
