An Act to Increase the Number of Domestic Violence Prosecutors. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative JABAR of Waterville; Cosponsored by Senator DAVIS of Piscataquis and Representatives: BAGLEY of Machias, GAGNON of Waterville, LaVERDIERE of Wilton, MUSE of South Portland, NORBERT of Portland, POVICH of Ellsworth, SAXL of Portland.
