LD 1378 / SP0422

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$35,200,000 for 6 of the State's Public Universities and the Maine Maritime Academy.  
New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$36,700,000 for the State's Public Universities, the Maine Maritime Academy and other Public Learning Centers. Presented by Senator CATHCART of Penobscot; Cosponsored by Representative THOMAS of Orono and Senators: MICHAUD of Penobscot, BROMLEY of Cumberland, DAGGETT of Kennebec, WOODCOCK of Franklin, YOUNGBLOOD of Penobscot, Representatives: BLISS of South Portland, BUNKER of Kossuth Township, DUNLAP of Old Town, PARADIS of Frenchville. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/23/01. Majority (OTP-AM) Accepted 06/21/01. Amended by: CA (Changed Title) S-350, SA/CA (Changed Title) S-373. Enacted, Signed 06/27/01, P & S LAWS, Chapter 37. Final Disposition: Approved in Referendum 11/06/01 (In favor: 124,395; Opposed: 91,238).
