Presented by Representative LORING of the Penobscot Nation; Cosponsored by Senator SCHNEIDER of Penobscot and Representatives: BLANCHARD of Old Town, CAMPBELL of Newfield, JACKSON of Allagash, MOORE of Standish, SIMPSON of Auburn, TUTTLE of Sanford, Senators: MITCHELL of Kennebec, SNOWE-MELLO of Androscoggin. Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 04/09/07. OTP-AM Accepted 04/09/08. Amended by: CB H-788 HB/CB H-923 SA/CB S-582. Enacted 04/10/08. Vetoed by Governor 04/15/08. Final Disposition: Veto Sustained 04/15/08.
