An Act To Repeal the School District Consolidation Laws. Referred to Jt. Standing Comm. on Education and Cultural Affairs. Public Hearing 04/01/09. Final Disposition: Died Between Houses 06/12/09. Referred to voters. Rejected in referendum 11/03/09 (In favor: 228,952; Opposed: 416,617).
