LD 1747 / SP0670

An Act To Allow the Town of Wells and the Town of Ogunquit To Amend the Terms of Their Cost-sharing Agreement for Their Community School District and To Provide Each Town the Ability To Withdraw from the Wells-Ogunquit Community School District. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator BOWMAN of York. Referred to Jt. Standing Comm. on Education and Cultural Affairs. Public Hearing 02/18/10. Final Disposition: Died Between Houses 04/05/10.
