Referred to Joint Standing Committee on Health and Human Services. Public Hearing 04/27/15. In House: Engrossed as Amended by HA; Insisted. In Senate: Minority (ONTP) Report Accepted; Adhered. Final Disposition: Died Between Houses 06/22/15.
