LD 1295 / IB0001

An Act To Require Legislative Approval of Certain Transmission Lines, Require Legislative Approval of Certain Transmission Lines and Facilities and Other Projects on Public Reserved Lands and Prohibit the Construction of Certain Transmission Lines in the Upper Kennebec Region. Referred to the Joint Standing Committee on Agriculture, Conservation, and Forestry. Ought Not to Pass Pursuant to Joint Rule 310 05/19/21. Final Disposition: Approved at Referendum, 11/02/2021 (In favor: 243,943; Opposed: 168,143), INITIATED BILL, Chapter 1.
