An Act To Require Telecommunications Companies To Divulge Location Information to Law Enforcement When Necessary To Respond to a 9-1-1 Call or Locate a Person in Danger. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Senator CYRWAY of Kennebec. Referred to the Joint Standing Committee on Judiciary. Public Hearing 01/14/22. Carried Over: 07/19/21. Final Disposition: Died Between Houses 04/11/22.
