Presented by Senator CURRY of Waldo. Referred to the Joint Standing Committee on Transportation. Public Hearing 01/11/22. Majority (OTP) Report Accepted 02/16/22. Final Disposition: Finally Passed, Signed 03/16/22, RESOLVE, Chapter 128.
