LD 1847 / HP1368

An Act To Prohibit a Public Utility from Terminating or Disconnecting Service to a Public Safety Facility without Advance Notice and Approval. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative BERRY of Bowdoinham. Referred to the Joint Standing Committee on Energy, Utilities and Technology. Public Hearing 01/25/22. Majority (OTP-AM) Report Accepted 03/31/22. Amended by: CA H-861. Final Disposition: Emergency Enacted, Emergency Signed 04/12/22, PUBLIC LAW, Chapter 586.
