Publisher's Foreword

This Supplement contains the Public Laws of Maine enacted at the regular legislative session of 1955, the regular and special sessions of 1957 and 1958, the regular and special sessions of 1959 and 1960, the regular and special sessions of 1961 and the regular session of 1963, and annotations to the Constitution and Revised Statutes taken from volumes 150 to 159, page 188, of the Maine Reports.

The form of the Supplement follows that of the Revised Statutes. New and amended sections are inserted under the proper chapter headings. Chapter analyses show new subdivision headings and old subdivision headings which have been changed to conform to changes in the statutes. The effect of each amendment is given in brief form in a note following the section. Where only a portion of a section has been changed by an amendment, the remainder of the section often is not set out, but attention is called to this fact in the note stating the effect of the amendment.

The acts not passed as emergency measures or expressly made effective on a later date are effective, under Article IV, Part Third, § 16 of the Constitution, as follows: On August 20, 1955, for the acts passed at the 1955 regular session; on August 28, 1957, for the acts passed at the 1957 regular session; on January 30, 1958, for the acts passed at the first special session in October, 1957; on April 17, 1958, for the acts passed at the second special session in January, 1958; on August 7, 1958, for the acts passed at the third special session in May, 1958; on September 12, 1959, for the acts passed at the 1959 regular session; on April 29, 1960, for the acts passed at the special session in January, 1960; on September 16, 1961, for the acts passed at the 1961 regular session; on March 3, 1962, for the acts passed at the special session in November and December, 1961; and on September 21, 1963, for the acts passed at the 1963 regular session. Where a new section or an amendment appearing in the Supplement was passed as an emergency measure or made effective on a specified date, the effective date is stated in a note.

A table showing where the acts are codified and an index will be found in the Supplement to Volume 5.
