#### STATE OF MAINE.

IN THE YEAR OF OUR LORD, ONE THOUSAND EIGHT HUNDRED AND THIRTY-FOUR.

### AN ACT to incorporate the Orrington Canal and Railway Company.

SECT. 1. Be it enacted by the Senate and 2 House of Representatives in Legislature as-3 sembled, That Samuel Thatcher junior, Tim-4 othy George, Nicholas G. Norcross, Joseph 5 Doane with their associates and successors, be 6 and they hereby are created a body politic by 7 the name of the Orrington Canal and Railway 8 Company with power to sue and be sued; to 9 have a common seal; to make by-laws for the 10 proper management of their affairs not repugnant 11 to the laws of the State; to take and hold real12 and personal estate to an amount not exceeding13 one hundred thousand Dollars; and to exercise14 all the powers and privileges incident to similar15 Corporations.

SECT. 2. Be it further enacted, That the 2 Proprietors of said Canal and Railway shall 3 have power to lay out and make a Canal, locks, 4 and dams, on the route beginning at the foot of 5 a pond at or near Timothy George's Mills, 6 thence extending southerly to the Great Brewer 7 Pond so called, in the town of Orrington in the 8 County of Penobscot, and thence continuing 9 said Canal or Railway on such route as may 10 be deemed most suitable and convenient to the 11 Penobscot River, said Proprietors to use the 12 waters of said Ponds for the purpose aforesaid. 13 Provided, That said Corporation shall not take 14 water from said Ponds for said Canal to the in-15 jury of persons owning water privileges connect-16 ed therewith.

SECT. 3. Be it further enacted, That a 2 toll shall be established and granted for the ben-3 efit of said Corporation, according to the rates 4 following, to wit, for the passage of pine, hem-

5 lock or spruce lumber from the head of said 6 Canal to the Great Brewer Pond, thirty cents, 7 for each and every thousand feet, board measure; 8 for the passage of ash plank or other hard wood 9 stuff, fifty cents for each and every thousand 10 feet board measure; for each ton of pine, hem-11 lock or spruce timber, ten cents; for each ton of 12 hard wood timber fourteen cents: for each thous-13 and of clapboards, twenty cents; for each thous-14 and of shingles, three cents; for each thousand 15 of red oak hogshead staves, thirty five cents; 16 for each thousand of barrel staves, twenty cents; 17 for each cord of wood or bark, thirty cents; 18 for all board logs, for every thousand feet board 19 measure, twenty five cents; masts and bowsprits, 20 three tons each and over, thirty cents; masts 21 and bowsprits under three tons each, twenty 22 five cents; for the passage of each boat through 23 said Canal, for each ton weight it is capable of 24 carrying, if loaded, forty cents, and if unloaded, 25 for each ton, twenty five cents; and so in pro-26 portion for all lumber, goods, merchandize and 27 other property transported through said Canal; 28 and ten cents for all boats, lumber or property 29 as before described, for each lock the same may

30 pass, in addition to the toll aforesaid. And 31 the following rates of toll are hereby allowed 32 and established on the Railway or Canal to be 33 constructed from George's Mills to the Penob-34 scot River as follows : for the passage of pine, 35 hemlock or spruce lumber, fifty cents for each 36 and every thousand feet board measure; for ash 37 plank and other hard wood stuff, seventy five 38 cents for each and every thousand, board meas-39 ure; for each ton of pine timber, twelve cents; 40 for each ton of hard wood timber. seventeen 41 cents; for each thousand of clapboards, thirty 42 cents; for each thousand of shingles, three 43 cents; for each thousand of red oak hogshead 44 staves, forty cents; for each thousand barrel 45 staves, twenty five cents; for each cord of 46 wood or bark, fifty cents; for all board logs, for 47 every thousand feet board measure, thirty five 48 cents; masts and bowsprits, three tons each and 49 over, fifty cents; masts and bowsprits under 50 three tons each, thirty five cents; and for the 51 passage of each boat through said Canal, for 52 each ton of weight it is capable of carrying, if 53 loaded, sixty cents, if unloaded, for each ton, 54 thirty five cents; and so in proportion for all 55 lumber, goods, merchandize, and other proper56 ty transported through said Canal; and for all 57 boats, or other property passing through each 58 lock, ten cents, in addition to the tolls aforesaid; 59 which tolls shall commence and be payable when 60 any part of said Canal or locks shall be passa-61 ble for any of the articles aforesaid. And the 62 said Proprietors shall have a lien upon the prop-63 erty which may pass through said locks and Ca-64 nals, for the payment of the toll due and paya-65 ble thereon according to the rates of toll above 66 specified.

SECT. 4. Be it further enacted, That if 2 any person or persons shall wilfully or mis-3 chievously destroy or injure said Canal or any 4 part thereof, or divert or obstruct the waters of 5 the same, to the damage of the Proprietors 6 thereof, he or they shall pay treble the amount 7 of such damage as the said Proprietors may 8 sustain, by reason of said trespass, to be recov-9 ered before any Court competent to try the 10 same.

SECT. 5. Be it further enacted, That the 2 said Corporation be and hereby are empowered 3 to erect any mills or machinery on any part of 4 said Canal below George's Mills aforesaid, and 5 at or near such dams as they may construct for 6 the use of said Canals. SECT. 6. Be it further enacted, That if
2 any person or persons shall have sustained inju3 ry by the location and construction of said Ca4 nals, and in case of any disagreement between
5 such person or persons and said Corporation,
6 the subject of the damages shall be submitted
7 to three disinterested persons; and in case said
8 referees should be unable to agree, the same to
9 be submitted to the Court of County Commis10 sioners of the County of Penobscot; the decis11 ion of either tribunal to be obligatory and final.
SECT. 7. Be it further enacted, That if
2 the said Proprietors shall neglect or refuse, for
3 the space of six years after the passing of this

4 Act, to open and complete said Canal, then this 5 Act shall be void.

SECT. 8. Be it further enacted, That any 2 two of the persons named in this Act are au-3 thorized to call the first meeting of the Corpo-4 ration, by giving fourteen days notice in some 5 newspaper printed in said County of Penobscot 6 previous to the time of said meeting.
