STATE OF MAINE.

IN THE YEAR OF OUR LORD, ONE THOUSAND EIGHT HUN-DRED AND THIRTY-FIVE.

AN ACT providing for the election of County Commissioners.

SECTION 1. Be it enacted by the Senate and 2 House of Representatives, in Legislature as-3 sembled, That on the second Monday of Sep-4 tember next, there shall be chosen in each Coun-5 ty within this State, by the written votes of such 6 persons as are qualified by the Constitution to 7 vote for Representatives in the several towns and 8 plantations, and cities of Portland and Bangor, 9 three discreet, suitable persons, inhabitants of 10 said County, as County Commissioners. The 11 persons so voted for, shall be severally designat-12 ed on the ballots, as First Commisioner, Sec-13 ond Commissioner, and Third Commissioner. 14 The votes for such Commissioners, shall be 15 counted and sorted in town or plantation meet-16 ing, by the Selectmen or Assessors thereof, and 17 the town or plantation Clerk. The names of 18 each person voted for, and the number of votes 19 given for him, shall be recorded in the town or 20 plantation book. An attested copy of such rec-21 ord shall be transmitted under seal, to the Clerk 22 of the Courts of the County, who shall lay the 23 same before the County Commissioners at their 24 next meeting, subsequent to said election. At 25 such meeting, the said returns shall be opened 26 and compared by the said Commissioners to-27 gether with the County Attorney and Clerk. 28 The person having a majority of votes for First 29 Commissioner, shall be Chairman, and shall 30 hold his office for three years, and until another 31 shall be chosen and qualified in his place. The 32 person having a majority of votes for Second 33 Commissioner, shall hold that office for two 34 years, and until another shall be chosen and 35 qualified in his stead. The person having a 36 majority of votes for Third Commissioner, shall

37 hold that office for one year and until another 38 shall be chosen and qualified in his stead. On 39 the day of election of State Officers, in the year 40 eighteen hundred and thirty six, and annually 41 thereafter, one Commissioner shall be chosen in 42 the above manner, in each County, to fill the 43 place of the one whose term shall expire at that 44 time, and shall hold his office for three years, 45 and until another shall be chosen and qualified in 46 his stead. Each Commissioner chosen agreea-47 bly to the provisions of this Act, shall be quali-48 fied to act as such, by being sworn before the 49 County Attorney or Clerk to the faithful dis-50 charge of the duties of his office. Whenever 51 any vacancy shall happen by the removal from 52 the County, death, failure in electing of any 53 Commissioner, or by the election of the second 54 or third Commissioner, to be First Commission-55 er, or in any other way, it shall be the duty of 56 the remaining Commissioners or Commissioner 57 to issue a warrant, directed to the Selectmen of 58 the several towns, and Assessors of the several 59 Plantations in the County, requiring them to 60 warn a meeting of the persons in their several 61 towns and plantations, qualified to vote as above 62 for the choice of such Commissioner or Com63 missioners, on the day of the next annual elec-64 tion of State or Town officers, whichever may 65 first happen. And the person or persons so 66 elected, shall hold their offices, respectively, for 67 so much of the term of the Commissioners in 68 whose place they shall be elected, as shall re-69 main unexpired. If the places of all the Com-70 missioners shall be vacant at one time, the Clerk, 71 or in case he shall be absent, or his office vacant, 72 the County Attorney shall issue a warrant, for 73 an election as aforesaid. Every thing in this 74 Act applicable to the Selectmen of towns, shall 75 be applicable to the officers who perform the 76 duties of Selectmen, in the cities of Portland 77 and Bangor.

SECT. 2. Be it further enacted, That the 2 County Commissioners elected agreeably to the 3 provisions of this Act, shall in their respective 4 Counties, have, exercise, and perform all the pow-5 ers, authorities and duties, which by law are now 6 exercised and performed by the County Com-7 missioners.

SECT. 3. Be it further enacted, That the 2 first section of an Act, entitled "An additional 3 Act, directing the method of laying out and 4 making provision for the repairs and amendment 5

5 of highways, and providing for the appointment 6 of County Commissioners," passed on the tenth 7 day of March, in the year of our Lord, one 8 thousand eight hundred and thirty one, and all 9 Acts and parts of Acts, inconsistent with the 10 provisions of this Act, shall be, and the same 11 hereby are repealed. This Act shall take ef-12 fect from and after the twentieth day of August 13 next, but the County Commissioners then in of-14 fice, shall continue to act as such, and till others 15 are chosen and qualified under this Act.
