RESOLVE making appropriations for Military
Purposes.

Resolved, That there be allowed and granted
2 for the purposes hereinafter named, the following
3 sums, to wit; nine hundred dollars for the al-
4 teration and repair of gun carriages; one hun-
5 dred and fifty dollars for the purchase of flannel,
6 matchrope, laboratory stores, and for transporta-
7 tion; five hundred dollars for the purchase of
8 musical instruments; fifty dollars for the pur-
9 chase of musical instruments for the use of the
10 fourth Regiment of the first Brigade and fourth

11 Division; five hundred dollars for the purchase
 12 of harnesses, tumbrels and apparatus for two
 13 new companies of Artillery in the first Brigade
 14 of the eighth Division, the several sums afore-
 15 said to be paid, whenever in the opinion of the
 16 Governor, with the advice of Council, the pub-
 17 lic service may require it. And for the expend-
 18 iture thereof the Acting Quarter Master Gen-
 19 eral shall be accountable.

Resolved further, That there be allowed and
 2 granted for the purposes hereinafter named, the
 3 following sums, to wit: two hundred dollars for
 4 the erection of a Gun house in Wiscasset, in-
 5 cluding a balance of forty-three dollars, in the
 6 hands of the Adjutant General remaining of an
 7 appropriation in the year eighteen hundred and
 8 thirty-five, "for the repair of the Gun house in
 9 Wiscasset;" two hundred dollars for the erec-
 10 tion of a Gun house in Bangor; seventy dollars
 11 to complete the repairs on the Gun house in
 12 Brunswick; three thousand dollars for the pur-
 13 chase of a site and the erection of a State Arse-
 14 nal in Augusta; two hundred dollars for the
 15 erection of a Gun house in Anson; two hundred

16 dollars for the erection of a Gun house in Har-
17 mony; fifty dollars for the repair of the Gun
18 house in Paris; fifty dollars for the repair of the
19 Gun house in East Machias; fifty dollars for
20 the repair of the Gun house in Westbrook;
21 seventy-five dollars for the repair of the Gun
22 house in Brownfield—The several sums afore-
23 said to be expended under the direction and at
24 the discretion of the Governor and Council.
