STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND THIRTY-EIGHT.

AN ACT additional to an Act, entitled “ An Act to
encourage the culture of wheat within this State”
—and giving a bounty on Indian corn.

SECT. 1. *Be it enacted by the Senate and House
2 of Representatives in Legislature assembled, That
3 the following shall be the bounty paid upon wheat
4 raised within this State, instead of the system pro-
5 vided by the Act to which this is additional, viz :
6 Ten bushels shall be the minimum, or least a-
7 mount for which a bounty shall be paid. To the
8 person who shall raise ten bushels of well cleansed
9 wheat, one dollar, and for every additional bushel
10 between ten and twenty bushels, ten cents, and
11 for every bushel above twenty bushels, [and less
12 than two hundred,] six cents, [and for every bush-
13 el over two hundred bushels, three cents.]*

SECT. 2. *Be it further enacted,* That there shall
 2 be a bounty paid upon Indian corn, raised within
 3 this State, according to the following system, viz :
 4 Thirty bushels of good sound ears of corn shall be
 5 the minimum, or least amount for which a bounty
 6 shall be paid. To the person who shall raise thir-
 7 ty bushels of good sound ears of corn, one dollar ;
 8 for every additional three bushels above thirty
 9 bushels, and between thirty and sixty bushels, ten
 10 cents ; and for every additional bushel above six-
 11 ty bushels, two cents ; to be paid in the same man-
 12 ner as provided for the bounty on wheat by the
 13 Act to which this is additional.

[SECT. 3. *Be it further enacted,* That all ac-
 2 counts for bounty under the provisions of this Act,
 3 and the Act to which this is additional, shall be
 4 presented to the Legislature for allowance, on or
 5 before the tenth day of March, annually, after the
 6 bounty shall accrue, and all accounts not so pre-
 7 sented shall not be allowed.]

SECT. 4. *Be it further enacted,* That all parts
 2 of the Act to which this is additional, inconsistent
 3 with the provisions of this Act, be, and the same
 4 are, hereby repealed.
