STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED

AND THIRTY-EIGHT.

AN ADDITIONAL ACT to prevent the introduction of paupers from foreign ports or places.

SECTION 1. Be it enacted by the Senate

- 2 and House of Representatives, in Legislature
- 3 assembled, That the Mayor and Aldermen of
- 4 the several cities, and the Selectmen of the sev-
- 5 eral towns of this State, may, at their election,
- 6 dispense with the Bond, required by the statute
- 7 to which this is additional, if the Master, Com-
- 8 manding Officer or owner of the ship, vessel or
- 9 boat in which foreign passengers may arrive
- 10 from foreign ports, or coastwise, shall, before the
- 11 landing of such passenger, pay into the Treasury

12 of the city or town, at which such vessel shall 13 arrive, such sum as said Mayor and Aldermen, 14 or Selectmen may think reasonable, not exceed-15 ing the sum of five dollars for every foreign 16 passenger whom he may intend to land, to be 17 appropriated as said cities or towns may direct 18 for the support of paupers.

Sect. 2. Be it further enacted, That the 2 said cities and towns shall have power respec-3 tively to appoint one or more visiting officers, 4 whose duty it shall be, on the arrival of any 5 ship, vessel or boat having on board one or more 6 passengers from foreign ports or places, who have 7 no settlement in this State, to go on board of 8 such ship, vessel or boat, and there remain until 9 the provisions of this Act, and the Act to which 10 this is additional shall be complied with. And it 11 shall be the duty of such officer to prevent the 12 landing of any such passenger until the provisions 13 of said laws have been complied with: and in 14 case of a violation of said laws, or an intention 15 to violate the same, to give immediate informa-16 to said Mayor and Aldermen or Selectmen. 17 And a reasonable compensation shall be paid to 18 such officer, by the Master, Commander, or

19 owner of such ship, vessel or boat, to be estab-20 lished by said Mayor and Aldermen, or Select-21 men.

- SECT. 3. Be it further enacted, That if any
- 2 Master or Commanding Officer of any such ship,
- 3 vessel or boat shall land any foreign passenger
- 4 at any place within this State, other than that
- 5 to which such ship, vessel or boat shall be des-
- 6 tined, with intent to avoid the requirements of
- 7 this Act, or the Act to which this is additional,
- 8 such Master or Commanding Officer shall forfeit
- 9 one hundred dollars for every foreign passenger 10 so landed.
