IN SENATE, March 18, 1841.

The Joint Select Committee on the apportionment of Senators and Representatives, to whom was referred the order of the Legislature of the 11th of February, 1841, directing them to apportion on the several Counties, Cities, Towns, and Plantations of this State, *two hundred* Representatives, and *thirtyone* Senators, agreeably to the provisions of the Constitution, have attended to that duty and ask leave to Report the following Resolves, which are herewith submitted.

STATE OF MAINE.

RESOLVE for dividing the State and Districts for the choice of Senators.

1. Resolved, That from and after the passing of 2 this Resolve, the State be, and hereby is divided 3 into Fourteen Districts for the choice of Senators, 4 and each District shall be entitled to elect the num-5 ber of Senators herein provided for the term of ten 6 years, in the manner prescribed by the Constitu-7 tion; to wit:—The several towns composing the 8 County of York, except the towns of Parsonsfield, 9 Cornish, and Limington, shall form the first Dis-10 trict, and be entitled to elect three Senators.

2. The several towns composing the County of 2 Cumberland, except the towns of Standish, and 3 Baldwin, shall form the second District, and be 4 entitled to four Senators.

3. The several towns and plantations composing 2 the County of Lincoln, together with the Island 3 of Matinicus, and Islands contiguous thereto, shall 4 form the 'l'hird District, and be entitled to four 5 Senators. 4. The several towns in the County of Kenne2 bec, together with Burnham, Troy, Unity, Freedom,
3 Palermo, Montville, and Liberty, shall form the
4 Fourth District, and be entitled to four Senators.

5. The remaining towns in the County of Wal-2 do, shall form the Fifth District, and be entitled 3 to two Senators.

6. The towns of Bucksport, Orland, Dedham, 2 Penobscot, Bluehill, Castine, Brooksville, Sedg-3 wick, Deer Isle, the plantations of Wetmore Isle, 4 Swan Island, Long Island, and the Islands west 5 of Long Island, in the County of Hancock, except 6 Matinicus, and the Islands contiguous thereto, shall 7 form the Sixth District, and be entitled to one Sen-8 ator.

7. The remainder of Hancock County, together 2 with the towns of Steuben, Cherryfield, Anns-3 burg, Beddington, Devereaux, Columbia, Harring-4 ton, Addison, and the Townships No. 30, 31, 24, 5 25, and 18, in the west division in the County of 6 Washington, shall form the Seventh District, and 7 be entitled to one Senator.

8. The Eighth District shall consist of so much 2 of the County of Washington as lies south of the 3 north lines of Wesley and No. 18 of the middle 4 division, No. 14 of the eastern division, Dennys-5 ville, Pembroke, including also Robbinston and 6 Calais, and shall be entitled to one Senator. 9. The remainder of the County of Washing-2 ton, together with the County of Aroostook, shall 3 form the Ninth District, and be entitled to one 4 Senator.

10. The several towns and plantations in the2 County of Penobscot shall form the Tenth District,3 and be entitled to three Senators.

The several towns and plantations in the
 County of Piscataquis shall form the Eleventh
 District, and be entitled to one Senator.

12. The several towns and plantations in the 2 County of Somerset shall form the Twelfth Dis-3 trict, and be entitled to two Senators.

13. The several towns and plantations in the 2 County of Franklin, except Carthage, Weld, Ber-3 lin, No. 2, 1st Range, No. 3, 1st Range, No. 2 4 and 3, 2d Range, and letters D and E, shall form 5 the Thirteenth District, and be entitled to one 6 Senator.

14. The remainder of the County of Franklin, 2 together with the several towns and plantations in 3 the County of Oxford, also the towns of Parsons-4 field, Cornish, Limington, Baldwin and Standish, 5 shall form the Fourteenth District, and be entitled 6 to three Senators.

RESOLVED, That hereafter, and until another 2 apportionment, the House of Representatives shall 3 consist of two hundred Members.


