ANDROSCOGGIN MANUFACTURING COMPANY.

STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT
HUNDRED AND FORTY-ONE.

AN ACT to incorporate the Androscoggin Manufacturing Company.

SECT. 1. *Be it enacted by the Senate and House*
2 *of Representatives in Legislature assembled, That*
3 David Dunlap, R. P. Dunlap, R. T. Duulap,
4 Isaac Lincoln, William H. Morse and their asso-
5 ciates and successors, be and they hereby are
6 constituted and made a body politic and corporate,
7 by the name of the Androscoggin Manufacturing
8 Company, with all the powers and privileges, and
9 subject to all the duties and liabilities provided in
10 the several laws of this State, regulating Manu-
11 facturing Corporations; and are authorized to
12 purchase and hold real and personal estate, not
13 exceeding in value at any one time the sum of five
14 hundred thousand dollars; and the same may
15 improve, lease, sell, and convey as other proprietors
16 of real and personal estate may lawfully do. And
17 said Company are authorized to carry on the man-
18 ufacture of cotton, wool, iron, and steel, lumber
19 and such other materials as may be necessarily or
20 conveniently connected therewith, in the towns of

21 Brunswick and Topsham, and may purchase,
 22 erect, and construct such machinery, mills, and
 23 other buildings, as may be useful for that purpose.

SECT. 2. *Be it further enacted,* That after
 2 two hundred thousand dollars of the capital
 3 shall have been assessed and paid, the Stockhold-
 4 ers in said corporation shall not be liable individ-
 5 ually, for the debts of said Company, *Provided*
 6 the Treasurer of the same shall annually publish
 7 in one or more newspapers printed in the County
 8 of Cumberland, a correct statement of the amount
 9 of capital so paid in, and also a correct statement
 10 of the debts due from said Company. *Provided,*
 11 that the debts of the Corporation shall not at any
 12 time exceed fifty per cent. of the capital stock of
 13 the Corporation actually paid in.
