#### RESOLVE

TO AMEND

### THE CONSTITUTION.

#### STATE OF MAINE.

In Senate, January 20, 1842.

RESOLVED, That section 2d, article 4th, part 1st, of the 2 constitution, shall be amended by striking out the follow-3 ing words and sentences, to wit: "The Legislature 4 which shall be first convened under this constitution 5 shall, on or before the fifteenth day of August in the 6 year of our Lord one thousand eight hundred and twenty 7 one, and the Legislature at every subsequent period of 8 ten years, cause the State to be divided into districts for 9 choice of Senators. The districts shall conform as near 10 as may be to County lines, and be apportioned according 11 to the number of inhabitants," and substituting the fol-12 lowing words and sentences :- "The Legislature in the 13 year of our Lord one thousand eight hundred and forty 14 three, and in the year one thousand eight hundred and 15 fifty one, and at every subsequent period of ten years 16 from the year one thousand eight hundred and fifty one, 17 shall cause the State to be divided into districts for Sen-Each Senate district shall contain as near as may 19 be an equal number of inhabitants, and shall at all times

20 consist of contiguous territory, and no County shall be

21 divided in the formation of a Senate district."

RESOLVED, That the aldermen of cities, selectmen of 2 the several towns, and assessors of the several plantations, 3 are hereby empowered and directed to notify the inhabit-4 ants of their respective cities, towns and plantations, in 5 the manner prescribed by law, at the annual meeting in 6 September next, to give in their votes upon the amend-7 ment proposed in the above Resolve, and the question 8 shall be submitted as follows: "Shall the constitution be 9 amended by adopting the first Resolve for the amend-10 ment of the constitution, passed by the Legislature, 11 proposing to apportion the Senate in the year of our 12 Lord one thousand eight hundred and forty three, and 13 in the year one thousand eight hundred and fifty one, 14 and at every subsequent period of ten years from the year 15 one thousand eight hundred and fifty one; and provid-16 ing that the Senate districts shall contain as near as may 17 be an equal number of inhabitants, and at all times con-18 sist of contiguous territory, and that no County shall be 19 divided in the formation of a Senate district?"

And the votes shall be by written or printed ballot, 2 and those in favor of said amendment voting "Yes," 3 and those opposed voting "No," upon the amendment 4 aforesaid, and said votes shall be received, sorted, counted, 5 recorded, declared, attested, sealed up and returned to 6 the office of Secretary of State, and in the same manner 7 as votes given for Senators. And the Governor and

- 8 Council shall open and count the same, and make report
- 9 thereof to the next Legislature the first week of its 10 session.

And it shall be the duty of the Secretary of State to

- 2 furnish blank returns to the several cities, towns and
- 3 organized plantations for the above named purpose.
