#### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FORTY-THREE.

AN ACT to ascertain the amount and description of estates and of certain description of persons within this State.

Be it enacted by the Senate and House of Represen-

2 tatives in Legislature assembled—as follows:

3 Section 1. On or after the first day of May

4 next, and before the first day of November next, the

5 Assessors of each city, town and plantation, within

6 this State, for the current year, shall take and record

7 in the books of such city, town or plantation, and

8 shall lodge in the office of the Secretary of State, a

9 copy of a true and perfect list of all the male polls of

10 twenty-one years of age and upwards, residents in,

11 or belonging to such city, town or plantation, on the

12 first day of May next, whether such persons are at

13 the time at home or abroad, distinguishing such as

14 are exempted from taxation, and of all rateable es-

15 tates, both real and personal; also, the just value of

16 each person's real and personal estate as specified in

17 the list hereunto annexed, lying within or adjacent

18 to their respective city, town or plantation, (not ex-19 empted by law from paying State taxes) expressing 20 by whom occupied or possessed, particularly distin-21 guishing such adjacent estate, and also each article 22 of such estate by itself, agreeably to the list hereto 23 annexed; and also a list of all persons supported in 24 whole or in part by such city, town or plantation, 25 with the average annual expense of supporting such 26 persons, excepting the real and personal estate of 27 any incorporated literary or religious institution; and 28 also the funds appropriated for the support of any 29 public school in this State. The polls of the stu-30 dents at any such institution, shall be taken in the 31 city, town or plantation where they respectively be-32 long. And such lists or inventories shall be made 33 in the following form: 34 The word annually in the following list shall be 35 construed to embrace an average period of three 36 years, immediately preceding May, A.   - Sec. 2. Said assessors, before they enter on this
  - 2 work, in order that the valuation provided for in the
  - 3 first section of this act, may be uniform, shall take
  - 4 the following oath:
  - 5 You one of the assessors of
  - 6 do swear or affirm that you will perform all the du-
  - 7 ties required of you as assessor by this act, without
  - S favor or prejudice, and that you will, according to
  - 9 your best skill and judgment, appraise all real and
- 10 personal estate according to the true value thereof,
- 11 without regard to any appraisement or valuation
- 12 heretofore taken. So help you Gop.
- 13 Which oath or affirmation may be administered

14 by any officer authorized by law to administer oaths
15 to town officers. And said assessors shall be paid
16 by the cities, towns and plantations to which they
17 respectively belong, for the time in which they shall
18 necessarily be employed in doing the duties required
19 by this act.

Sec. 3. If any assessor of any city, town or 2 plantation for the year eighteen hundred and forty 3 three, shall refuse or neglect to take the oath or af-4 firmation required by this act, or shall refuse or neg-5 lect so to do and perform all the duties required by 6 this act, or shall in any way act deceitfully or eva-7 sively therein, he shall for each such offence forfeit S and pay a fine not less than fifty, nor more than two 9 hundred dollars. And every person liable to be 10 taxed, and not out of the State, on and from the first 11 day of May next, to the first day of November 12 next, who shall refuse or wilfully neglect to give the 13 assessors on oath or affirmation when required, which 14 said assessors are hereby empowered to administer, 15 a true and perfect account of all his or her estate, 16 and of all estates in his or her hands, or under his 17 or her care, as agent, according to the true intent 18 and meaning of this act, shall be doomed by said 19 assessors to the full amount of his or her estate ac-20 cording to their best skill and judgment, and shall 21 pay a fine of six per cent. on the whole amount of 22 the sums in which he or she shall have been thus 23 doomed by the said assessors.

- SEC. 4. The Secretary of the State shall forth2 with cause to be made and printed a sufficient num3 ber of blank lists with columns for each article re4 quired by this act, and proper titles to each column,
  5 and transmit to the clerk of each city, town and
  6 plantation in this State, a suitable number of copies
  7 of the same, and of this act, for the use of the asses8 sors of each city, town and plantation, by mail or
  9 otherwise.
- Sec. 5. The said assessors shall, on or before 2 the first day of November next, transmit to the of-3 fice of the Secretary of State, a true and attested 4 copy of the inventory and valuation by which the 5 assessors of the respective cities, towns and plantations made their respective taxes for the year eighteen hundred and forty two, and all fines, penalties 3 and forfeitures incurred by any breach of this act, 9 may be recovered by action of debt in any court of 10 record proper to try the same, one moiety thereof to 11 him who shall sue for the same, and the other moiety 12 to the use of the State.
  - Sec. 6. The Treasurer of this State or his suc-2 cessor in office shall cause to be ascertained the num-3 ber of acres of wild land situated in this State, which 4 are without the limits of any incorporated city, town 5 or plantation where assessors are elected according 6 to law (and which wild lands are owned by non-res-7 ident proprietors), and liable to be taxed. And the 8 said Treasurer shall cause a true and correct list to

- 9 be made of the same, and also of the several coun-
- 10 ties wherein the same are situated. And on or be-
- 11 fore the first day of November next, the said Treas-
- 12 urer shall transmit a copy of said list to the Secre-
- 13 tary of State for the time being.
