*Amendment offered by Mr. Smart to the Bill introduced  
by Mr. Walker.*

Amend the first section as follows :

Strike out all after the tenth line in the first section,  
and insert—

The county of Kennebec, except those towns in  
2 Kennebec included in the fifth district, together with  
3 the towns of Lisbon, Lewiston, West Bath, Bowdoin,  
4 Bowdoinham, Phipsburg, Richmond, Topsham, Web-  
5 ster, Arrowsic, Dresden, Georgetown,\* Wiscasset,  
6 Woolwich, Perkins, Alna, Westport, and the city of  
7 Bath, in the county of Lincoln, together with the  
8 towns of Fairfield, Bloomfield, Mercer, Norridgewock  
9 and Smithfield, from Somerset county, shall compose  
10 the third district, and be entitled to one Representa-  
11 tive.

12 The county of Waldo, together with that part of  
13 Lincoln not annexed to the third congressional dis-  
14 trict, with the towns of Windsor, China, Winslow,  
15 Albion, Benton, Clinton, Clinton gore and Albion

16 gore, in the county of Kennebec, shall compose the  
17 fourth district, and be entitled to one representative.

18 All of the county of Penobscot not included in the  
19 sixth district ; the county of Piscataquis, and the re-  
20 mainder of Somerset not included in the third district,  
21 shall compose the fifth district, and be entitled to  
22 one representative.

23 The counties of Hancock, Washington and Aroos-  
24 took, together with the towns of Brewer, Clifton,  
25 Eddington, Orrington, Bradley, Greenbush, Milford,  
26 Passadumkeag, Burlington, Lowell and Enfield, in  
27 the county of Penobscot, shall compose the sixth dis-  
28 trict, and be entitled to one representative.
