### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-THREE.

AN ACT to authorize the inhabitants of one or more towns to form themselves into a Mutual Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Such of the inhabitants of any one or 2 more adjoining towns, as desire so to do, may form 3 themselves into a mutual insurance company, for the 4 purpose of insuring buildings and other property, in 5 such town or towns, against loss by fire. When any 6 number of the inhabitants, not less than twenty, of

7 any town or towns in this state, shall be desirous of 8 forming themselves into such insurance company, 9 they may, at a meeting called in any manner, sign a 10 declaration setting forth that it is their desire and 11 purpose to form such company, and at such meeting 12 they may adopt a corporate name by which they shall 13 be known, and may organize by choosing a president 14 and a secretary, and at the same or a subsequent 15 meeting, may choose a board of directors, to consist 16 of not less than seven, and a treasurer, and adopt a 17 code of by-laws for the management of their affairs; 18 a copy of the said agreement, and of the doings of the 19 said meeting, and of the by-laws adopted, shall be 20 recorded in the town records of the town or towns 21 for which said company is formed, and it shall be the 22 duty of the town clerk of each town, on his fees 23 being paid, to record the same, and thereupon the 24 said company shall have a legal corporate existence, 25 with all the powers necessary for the well managing 26 of a mutual insurance company.

SECT. 2. Whenever application shall be made to 2 such company by inhabitants of said town or towns, 3 for insurance on buildings and personal property in 4 said town or towns, to an amount not less than twenty

5 thousand dollars, the company may issue policies on 6 said application, and having done so, they may con-7 tinue to issue policies on application for insurance 8 on buildings and personal property in said town or 9 towns, whether owned by inhabitants or not, to any 10 amount allowed by the by-laws of said company.

SECT. 3. The secretary of such company shall, an-2 nually, on the first day of January, make a statement 3 in writing, showing what amount is then insured and 4 at risk by said company, and he shall sign and make 5 oath to the same, and within three days deliver the 6 same to the town clerk of the town, and if more than 7 one town, then one to each clerk, to be filed by him 8 in his office; and he shall make a like statement by 9 him signed and sworn to on the first day of July, in 10 each year, and deliver the same within three days to 11 such clerk or clerks, to be filed, and he shall pay for 12 each statement so filed, to the clerk ten cents for his 13 fees for filing the same, and the same shall remain in 14 the office of the town clerk, open to inspection, at rea-15 sonable hours, to any person. If any two successive 16 statements, so made, shall show the amount insured 17 by such company to be less than twenty thousand 18 dollars, such company shall immediately cease to issue

19 policies, and with as little delay as may be consistent 20 with right and justice, it shall close its affairs, taking 21 up its policies and restoring its premium notes, after 22 having paid or made reasonable provision for pay-23 ing all claims against it, and shall thereupon be dis-24 continued.
