STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-FOUR.

AN ACT concerning the transfer of bonds and other writings for deeds.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Every assignment or transfer of any 2 bond, obligation or any other contract for the con-3 veyance of real estate, on the payment of money, or 4 the fulfillment of any other condition in the same 5 specified, shall be signed by the party making it and 6 witnessed. And no such assignment or transfer shall 7 be good and effectual against attaching creditors, or 8 any person other than the assignor, his heirs and

9 devisees, or persons having actual notice thereof, 10 unless the same assignment, together with the instru-11 ment or writing so assigned, shall be recorded in the 12 registry of deeds office in the county where such real 13 estate lies, in the same manner as of deeds.

SECT. 2. This act shall not affect any bond or 2 transfer heretofore made.

SECT. 3. This act shall take effect and be in force 2 from and after its approval by the governor.

TRANSFER OF DEEDS.

AMENDMEN'TS.

Α.

Amend by striking out the second section and by 2 inserting in the first section before the word "shall", 3 in the seventh line, [sixth line printed bill,] the words 4 "hereafter made".

SECT. 2. No assignment or transfer of any such bond 2 or other contract as specified in the preceding section, 3 which shall have been made before this act shall take 4 effect, shall be good and effectual against attaching 5 creditors or any person other than the assignor, his 6 heirs and devisees, or persons having actual notice 7 thereof, unless the said assignment and contract shall 8 be recorded in the registry of deeds for the registry 9 district wherein such real estate lies, on or before the 10 first of September next.
