## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-FIVE.

AN ACT for the establishment of Normal Schools.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. There shall be established in differen
- 2 parts of the State, in the manner herein provided,
- 3 three Normal Schools or Seminaries, for the training
- 4 of teachers of Common Schools, in the science and art
- 5 of teaching.
  - Sect. 2. There shall be appointed by the Governor
- 2 and Council eight Trustees, two of whom shall, in
- 3 the first instance, hold their office for one year, two
- 4 for two years, two for three years, and two for four
- 5 years, the term of office to be by them determined by
- 6 lot or otherwise, the vacancies to be filled by ap-

- 7 pointment by the Governor and Council for the resi-
- 8 due of the term which shall become vacant; and the
- 9 Superintendent of Common Schools shall, ex-officio,
- 10 be a member of said board, and President thereof.
  - Sect. 3. The expenses necessarily incurred by the
  - 2 Trustees in the discharge of their duties, shall be
  - 3 defrayed out of the funds herein appropriated for
  - 4 the support of said schools; but they shall receive
  - 5 no compensation for their services.
  - Sect. 4. To the Board of Trustees shall be com-
  - 2 mitted the location of said schools; the application
  - 3 of the funds for the support thereof; the appointment
  - 4 of Teachers, and the power of removing the same;
  - 5 the power to prescribe the studies and exercises of the
  - 6 schools, and the rules for their management; and they
  - 7 shall report annually to the Legislature, their own
  - 8 doings, and the progress and condition of the schools.
    - Sect. 5. Whenever any person or persons, shall
  - 2 offer to the Board of Trustees, the necessary buildings
  - 3 and apparatus for the accommodation of not less than
  - 4 two hundred pupils, in accordance with plans and
  - 5 specifications furnished by the Trustees, and shall
  - 6 place the said buildings and apparatus at the disposal

- 7 of the Trustees, for the use of the State, then the
- 8 Trustees accept the same, and establish in the build-
- 9 ings thus provided, a State Normal School, and shall
- 10 appropriate for the expenses thereof, one-third part of
- 11 the sum herein provided for the support of Normal
- 12 Schools; and the location of each of the other schools
- 13 shall be determined in the same manner.
  - Sect. 6. In determining the location of the schools
  - 2 contemplated in this act, due regard shall be had to
  - 3 the wants of the different parts of the State, to the
  - 4 eligibility of the site, and to the quality of the build-
  - 5 ings offered to the Trustees.
  - Sect. 7. Each of the Normal Schools shall be
  - 2 open for the admission of youth of both sexes; and
  - 3 all applicants for admission to the same, shall present
  - 4 a written declaration, signed with their own hand, that
  - 5 their object in seeking to enjoy the privileges of the
  - 6 school, is to qualify themselves for the office of Teach-
  - 7 ers, and that it is their intention to engage in that
  - 8 employment in this State.
    - Sect. 8. To all the pupils admitted to these
- 2 schools, the tuition and all the privileges of the school
- 3 shall be gratuitous.

- Sect. 9. The Trustees shall make provision for the
- 2 model schools, under permanent teachers appointed
- 3 by them, to be connected respectively with the three
- 4 Normal Schools, and in which the pupils of the Normal
- 5 Schools shall have opportunity to practice the methods
- 6 of instruction and discipline inculcated in said schools
  - Sect. 10. For the support of said Normal Schools,
- 2 there is hereby appropriated, from the proceeds of the
- 3 State tax on banks, the annual sum of \$12,000; and the
- 4 Governor, with the consent of the Council, is hereby
- 5 authorized to draw his warrants on the Treasurer ac-
- 6 cordingly.
- Sect. 11. All acts and parts of acts inconsistent
- 2 with this act, are hereby repealed.
- SECT. 12. This act shall be in force from and after 2 its approval by the Governor.
