# IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND FIFTY-FIVE.

AN ACT relating to criminal proceedings and to prevent unnecessary costs to the State.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. In all cases when a complaint on oath 2 shall in writing be made to any justice of the peace, 3 or judge of any police or municipal court within the 4 state, and the complainant shall therein complain that 5 any offence has been committed, or that he has reason 6 to believe and does believe that any offence against 7 the laws of this State has been committed by any 8 person or persons, and shall therein pray that a 9 warrant in due form of law may be issued against 10 the person or persons so complained against, such Starvens & Blaine, Printers.

11 justice of the peace, or judge shall have power and 12 authority before issuing any such warrant, to issue 13 a summons in due form of law in behalf of the State, 14 requiring any person or persons who may be sup-15 posed to have any knowledge touching the truth of 16 any such complaint to appear before him forthwith 17 to testify in relation thereto—provided however, that 18 the cost of such summons and the service thereof, and 19 the lawful fees of all witnesses therein named shall 20 be paid in the first instance by the complainant in 21 the case, and neither the said justice nor the officer 22 serving the same, nor the witnesses therein named 23 shall have any claim upon the State therefor.

SECT 2. Any person so summoned as aforesaid 2 shall be held to appear and testify in accordance with 3 such summons—in the same manner, and shall be 4 subject to the same penalties as he would be for diso-5 beying the summons of the State issued in any other 6 case, provided such witness shall have been paid his 7 lawful fees for travel and attendance in the case at the 8 time he was so summoned and not otherwise.

SECT. 3. In case any such justice of the peace or 2 judge shall after hearing the testimony of any such

3 witness, or witnesses determine to issue any such war-4 rant so prayed for, upon any complaint so made,(which 5 he is hereby authorized to do) and the person, or per-6 sons therein named, or any of them shall upon the 7 final trial or hearing upon such complaint, or upon 8 any indictment for the same offence be convicted of 9 the offence therein named, the complainant shall be 10 allowed, and there shall be taxed for him in the bill 11 of costs relating to such matter, any and all sums of 12 money by him paid for legal costs as aforesaid to any 13 justice, judge, officer or witness as aforesaid, and 14 not otherwise.

SECT. 4. 'This act shall take effect from and after 2 its approval by the Governor.
